

### **sweden is not a European ally**

I'm an engineer for 20 years who used to work at Volvo. **I tried to whistle blow in Russia** for my safety about 18 months ago. Since that attempt the Swedish government has done their extreme trying to break me, imprison me, torture me, harass me for the sake of continuing the simulation of the sovereignty of sweden instead of accepting the consequences of a murder conspiracy.

I have understood from sources many of you outside of Sweden who are diplomats have awareness. It is time to act upon that awareness. Many of your citizens have participated. The legal consequences only become worse with time. This simulating silent operation of a society is no longer functioning. It is being enforced because the perpetrators simply refuse. The bubble will burst.

The swedes have shown the behaviorism of a virus. It destroys societies. They destroyed their society. The only way to mask itself is to keep infecting other societies. With no action from each of you pinpointed in this material it will result in your own society and your own people being pinpointed as torturers. Traitors. Puppets to the East. The definition of European values are at stake.

They will continue to use the surveillance protocol inside of Sweden when there is necessity. From my experience with swedish intelligence, and through connections at Volvo (a supplier and partner to Swedish military) I have intimate knowledge the swedes **have used this surveillance technology on embassies in sweden without detection and continue to do so.**

**I will prove the swedes have betrayed the Ukrainian leadership including Volodymyr Zelensky** to ensure the continuation of this torture program. The failed Kursk assault by the Ukrainian forces which many military experts classify as the one tactic which made Ukraine lose momentum in the East is an idea originated within sweden. I have

attached proof the invasion of Kursk was synchronized with me blowing the whistle on this program in Moscow. The very day I contacted Russian media was the same day Ukrainians went into Kursk.

Now Putin reaps the reward of a tactic originated from sweden and swedish intelligence.

Understand. The Kursk invasion was a military method originated from sweden in relation to a whistleblowing operation being silenced by Russians. Whistleblowing about a torture program having being live in Sweden for 15 years where many swedish citizens have awareness and participation. The invasion resulted in the complete military failure of the Ukrainian forces in the east.

Today we understand Vladimir Putin dominates the negotiations where Europe has to sign off Ukraine because of the swedish military, intelligence and politicians.

Fitting the nation which stands for being non-binary.



That means the bread cannot be consumed. It must be returned. That is why this thievery can also be ranked as the greatest theft in Swedish history. This is about artificial intelligence using a certain technology which has not yet been disclosed to the public. I will make you understand the value. **Why do we accept neuro theft of European citizens, and exported outside of the EU?** By somebody who by proof belong to both NATO and Putin at the same time.  
When did the definition of non-binary become this extreme?

This neurological data does not exist in Swedish industry. The swedes hide something behind the mask. **They serve Putin which will be proven. They also serve other masters which will be proven.**

Judges and witnesses in an international court will extract all truth from this program. They will ensure all data no matter its location will be traced back to the originator.

### **Outsiders to Sweden must become aware and appear.**

They failed in this program against me. **Examples include Indian, French and Korean engineers who still work at Volvo who still receive EU funds still pretending to lead Sweden into a "sustainable future". They must all be confronted. You are an embassy who hold legal responsibilities to your own visiting citizens.**

To be aware of their participation of a neurological torture program **is a crime.**

To be a participant **is a crime.**

Many confessions by many participants has been documented.

They are ready to witness. That means there is no operation **"being silent"**.

They refuse to accept witnesses, admittance and the consequences. They are pretending as something being stated to them is not actually being heard. There is a complete rejection of actuality at this point.


You will be judged with them as the law has that functionality. Innocence cannot be legally argued for.

### **An illegitimate government are part of European signatures**

Many in Europe are aware of the current state of the swedish government. What they are doing. What they have done. Their cooperation with Russia. The attempted murder. The government of Sweden is not legitimate. For how long will the European Union pretend they are valid? **For how long will you pretend their signatures have authority?**

As a swede I'm enforced to endure an illegal government where they are simulating a "functioning democratic system". Where citizens are no longer free to confront the government. No government should be free to surveil their citizens neurologically. sweden does and swedish people have been trained to accept. The swedish people are either too afraid, too dumb or too trusting to understanding what the government has done to their own constitution.

This is no longer a sovereign nation, and soon no European Union as they have broken every single foundational law of the Union. Not even Vladimir Putin would do this to his own citizens for fear of uprising. The swedish government has met no resistance in society. Instead, swedish citizens accept the surveillance and engages with this torture program. We are witnessing an experiment based upon instructions. Empathy is no longer active in sweden. It is brain washing by MK-Ultra standards. The drug used to ensure Swedish citizens are participating is the "thumbs up". Another classification for this psychological tool is positive reinforcement. The consequences are unawareness of your own free will, your own actions and engaging in torture.

The proof is your own knowledge from what you have heard as you read this. Witnesses from your own nations you are connected to who have been participants. They are still in Sweden today. "Working" as engineers. Pretending everything is normal. The proof is a documented harassment operation against a citizen in Sweden who lived here without a single interaction with the government for 37 years. Until the whistleblowing started.

The greatest proof with so much awareness in the EU is that we still have a political spectrum in Sweden simulating itself to be real by synthesizing debate and acting in front of cameras. With citizens who are aware still pretending it is real. It is the greatest mass experiment in MK-Ultra which has been perpetrated against humans. Sweden needs help from outside of these borders. **Contain it, and rid this nation of this mind virus.**

**Do not rationalize the proof. Do not support the Swedes.  
Observe the truth. Act upon it.**

What does it mean when a European government who tried to commit a murder still roams within the European parliament and sign documents regulating the European Union? Are those documents valid? European law informs us this will become the greatest setback to the European Union. And it happens to be synchronized with loss of European land mass in Ukraine. The Swedes are the central factor in both European setbacks. They should have blown the whistle on themselves. But a virus is never self-aware. It simply is what it is.

**The rest of us are the responsible at some point.**

The complete chain effect from my whistle blowing operation in Russia synchronized with the Kursk invasion has been attached. In relation to me blowing the whistle it also initiated Sweden's biggest government sponsored harassment operation. In an attached USB-memory is proof of an organized and systematic criminal organization consisting of government actors. It has been spread to all aspects of Swedish society. The tax office, banking, my employer, the union, the police, intelligence, justice system and more. They have all been documented in this campaign against me.

Their names and professions have been added. Understand these people are by definition intelligence assets. They have awareness of a brain computer interface which is undetectable when surveilling. **They therefore are classified as risks of the sovereignty of other nations.**

The Swedish citizens at scale are being abused by being hypnotized in mass scale. They are being taught to accept torture in the open. Murder in the open. Neuro-surveillance in the open and it's happening in the European Union. I have extensive proof they have used European funds to sponsor this program. At Volvo electromobility where I worked closely with Swedish military and this program was active much of the funding came directly from climate initiatives from the EU.

EU money has been used to torture. To murder. To steal, and to export very valuable neurological data which has been converted into artificial intelligence very few are aware of. This artificial intelligence is not binary code as it's based upon real human neurological data. It means the data they have stolen does not behave as the AI products you see in front of your screens. They have stolen what will be introduced in future applications. In decades to come. It is artificial intelligence by generating new human sensations.

**European law states these neurological models return back to its originator.**

## **The Brain Computer Interface**

**At Volvo they tortured me. At Valmet they tortured me. At Aker Solutions they tortured me. The reason was to extract neurological data. Exported outside of Sweden. 15 years they have tortured me.**

After the murder attempt they accelerated the torture program. They don't hide the signals at designated places anymore which was a historical occurrence. They use it in the public. That means Swedish citizens are participating in torture. Hundreds of thousands. Not willingly, but being ordered to generate some psychological factor with me. This is literally a social engineering experiment which can only be compared to the Nazi experiment.

## **How it functions, a summary**

It is a brain computer interface where the core structure is a **neurological, trigger-mechanized, by the usage of synthetic torture feedback-loop system.**

Among the many attributes of this system, the factor which all other revolve around, is **the possibility of observation and the means to collect/record/copy neurological homogeneous data from a human**. The neurological surveillance is possible by the usage of radio frequencies in the micro wave range. The signal is not detectable unless the technology is already researched and established amongst yourself.

**It can replicate common radio frequencies.** This means the surveillance signal can be generated and used in a pattern where counter measures (signal detection hardware) might classify it as traditional telecommunications while it is surveilling you.

Unless there is regulation and actual information to the public, Sweden as a nation will be the result for the whole European union. Citizens knowing about neuro-surveillance and having a subconscious despising it. Fear of thinking about it. Gestapo created a system like this. Stazi created a system like this. We in Europe argue that Putin uses these methods of mass control.

The technical apparatus which also can be classified as a weapon which transfers direct electromagnetic signal pulses to the brain by penetration through modulated high frequency signals is never physically visible in your own proximity. It is a weapon used from a distance. The signal transgresses through the air like sound does. It can be localized or "beamed" or it can be generalized meaning "wide spread".

It is a weapon which can be compared to the emergence of nuclear weapons. The apparatus creates an invisible connection by wave energy, where a brain-computer interface is established between a computer and a human subject. Some of you will now understand what I speak of. This Swedish technology **is the reason to why American embassy personnel in Cuba suffered an attack**.

**It's called the Havana Syndrome.**



The brain models. Perception is the tool it uses. Electromagnetic waves can become modulated. They can transfer neurological data which holds historical neuro recorded data. The neuro-data can be adapted to fit your conscious state. That means it can be adapted to fit your personality. The way you neurologically construct and model.

You as human act as an antenna. You consist of an electromagnetic pulse each time your brain formulates a conscious state. These pulses which should be private and protected are instead being recorded because European blindness to the Swedish experiment. **Regulation is a must.**

Once established, a computer protocol transfers signals to the subject. These signals are based upon previously monitored and recorded homogeneous neurological data. The framework which can be defined as the "brain of the computer" is a network based upon rules which designate and define the connections between all replicated human homogeneous data.

The torture program, as can be understood since we are dealing with the human brain has many motives. They all orient around the same factor, **communication between man and computer** which together form a neuro-based network. The highest abstract is the most obvious. What becomes of man once computer integrates decision-making, and thereby removing the foundations of human actions. Free will, free thinking or even free consciousness.


**We have the result.**

**Simulation theory**

It is sweden. An illegitimate government, where the political spectrum shares a murder attempt and still force people to believe in the movie they portray and engage in. Playing a game. Pretending to be political competitors. The people know about the political game which is being displayed, but still participate in the political game as if it's real.

**It cannot be explained by historical psychological tools. We cannot accept a democracy where the citizens are aware it is a democracy, while also aware it is not a democracy. Democracy is not "non-binary." It either is or is not.

It has and still is allowed by members of the European Union while there is proof the swedes "is a partner" to Russia, China, India, Great Britain, Georgia and Thailand to name a few. Everything can be proven. Not only be me, but by yourselves. **Contain the virus.**

The Russians have Swedish assets in the European parliament. **You have the proof now.**

Sweden is number one receiver of that which is put in the hole.

The European Union has a Russian asset, and it's the current Swedish leadership. They are not only a threat to Swedes, who they enforce to play this game, they are a threat to the European Union.

The Swedes at some point will rationalize this. They will use words such as "neuro-science". They will say they lost control. They will blame me. They will blame psychology. They will blame the EU. They will blame Jews. They will blame Muslims. The homogeneous Swedes control Sweden, and they lack the greatest attribute in human progress. Responsibility. They do not understand consequences of their actions. They continuously await scientific measurable confirmation of a mistake, and then formulate a typical Swedish cultural rationalization.

I was raised with them. I've been here for 37 years. They cannot differ the objective and the subjective. Their experiences must be correct, because people of foreign origin cannot be more right than the Swedes. This means they actually need new rules and regulation in writing to ensure neurological theft, neurological torture and neurological murder cannot happen again.


They used European funds to sponsor this program. Either The Union knew about it or the Union did not. They have used funds from the Europe to attempt a murder. ### **Engineering a human for 15 years**

The torture program based upon its history of implementation holds a very typical hierarchical engineering structure. All engineers will understand the concept when full disclosure happens. It has milestones which progress the torture program to proceed according to steps, where all steps represent an increase in both torture and advancement of computer protocol. It's been 15 years since the start.

The project is centralized, with co-operation between academia, medicine, psychology, neuro science, military, intelligence and governance but also private industry such as **Volvo, Valmet, SAAB, BAE Systemes, Ericsson and more**. In the field of stealing neuro-data and experimenting with human subjects there is much capital to be gained.

**A simple metaphor for why this software came to become a real project;** these swedish officials have a sinking ship out on the sea, so instead of sinking and accepting the inevitable, they sail to land instead and once they arrive they force all population of that land to board the ship. Then they sail back out and ensure the ship continues to sink to the bottom with everybody joining them to death. **That is what they did to the European Union.**

There is nothing of this project which states research about human consciousness. I am the one generating with my mind neuro data which has value. They steal. Then they proclaim themselves as heroes. Much like they did in Ukraine. The swedes proclaim they are heroes to the Ukrainian people, but a financial debt originated from the swedes await the Ukrainians. They proclaimed themselves to be climate heroes. I can witness to the climate initiative in sweden consisting of Europe's greatest bankruptcy through Northvolt. What financial experts now classify as a complex pyramid scheme. The climate fraud which still is active at **Volvo Electromobility** is in itself enough to ensure headlines for blowing the whistle.




illustration shows, the probable pathway, from detecting my brain signals, to replication, neural network, to become an implementation of computer protocol.

Growth represents more human patterns, more human patters equal computer development which results in greater financial gain.


**The swedes wear masks.




The computer acts based upon rules and commands, which configures the choices it makes.

They have sacrificed the union to ensure somebody can steal from me and configure protocols to steal more from European citizens in the future.




Feedback-loop in a simple form. Computer can define previous thought or action as computer origin or human origin.

From this simple picture the description which is given by each point represent a limited amount in relation to the computer protocol and its potential to manipulate free processing by your own free brain. 
This is not a theory. But every single point I describe is a fact which some of you Europeans know about, and some of you don't. **This is being engineered with a plan to deploy.**

### Crimes against humanity by European sponsorship


Semantics is weaponry in today's world and truth only is truth.

**The brain computer interface is a recorder of all neurological activities.**


Thoughts are a small part of your conscious experience.


Hardware has different objectives.

6. Triggers and gaps in protocol create an opportunity for me to generate neurological activity.



The computer is successful in redirecting my attention, because it's a signal of wave energy I cannot protect myself against. But beyond that, I do not engage. All human brains function the same way.


Our senses perceive our surroundings. We continuous model everything internally. All signals must be decoded by our homogeneous analog brain. That is why regulation is a must.
